壹、股東會議事規則

第一條、(前言):

為建立本公司良好股東會治理制度、健全監督功能及強化管理機能,爰訂定本股東會議事規則(下稱「本規則」),以資遵循。

第二條、(總則):

除相關法令或本公司章程大綱及公司章程(下稱「章程」)另有規定者外,本公司股東會議事應依本規則之規定。

所有於本規則中使用但未加以明確定義之用語,均與其在章程中之意義相同。

第三條、(股東會之召集及通知程序):

本公司股東會除法令或章程另有規定外,由董事會召集之。

董事會經繼續一年以上持有已發行股份總數百分之三以上股份之股東依章程規定請求 董事會召集股東臨時會而於股東提出請求日起十五日內未為股東臨時會召集之通知 時,提出請求之股東得依據公開發行公司法令,自行召集股東臨時會。

股東會之召集,應編製議事手冊,並依相關法令和章程規定之時間與方式,於股東會十五日前將議事手冊及其他相關資料於中華民國證券主管機關指定之公開資訊觀測站公告申報之。股東會召集之通知,常會應於開會日之三十日前通知各股東,臨時會應於十五日前通知各股東。

通知及公告應載明召集事由;其通知經股東事前同意者,得以電子方式為之。

與下列有關之事項應載明於股東會通知並說明其主要內容,且不得以臨時動議提出:

- 一、選舉或解任董事;
- 二、修改章程;
- 三、解散、合併或分割;
- 四、訂立、修改或終止關於出租本公司全部營業,或委託經營,或與他人經常共同經營 之契約;
- 五、讓與本公司全部或主要部份之營業或財產;
- 六、受讓他人全部營業或財產而對本公司營運有重大影響者;
- 七、許可董事為其自己或他人從事本公司營業範圍內事務之行為;
- 八、以發行新股方式分配本公司全部或部分盈餘、法定公積及其他依本公司章程規定款 項之資本化;
- 九、本公司私募發行具股權性質之有價證券。

第四條、(委託書):

股東得依據本公司章程以本公司核准之格式之委託書,載明授權範圍,委託代理人,出席股東會,並載明該委託書僅為特定股東會所為。

委託書格式內容應至少包括填表須知、股東委託行使事項及股東、受託代理人及徵求人 (若有)基本資料等項目,委託書用紙並應與股東會召集通知同時提供予股東,並應於 同日分發予所有股東。

一股東以出具一委託書,並以委託一人為限,應於股東會開會五日前送達本公司登記處

所或送達股東會召集通知或本公司寄出之委託書上所指定之處所,委託書有重複時,以最先送達者為準。但股東在後送達的文件中明確以書面聲明撤銷前委託者,不在此限。委託書送達本公司後,股東欲親自出席股東會者,應於股東會開會二日前,以書面向本公司為撤銷委託之通知,該通知應敘明撤銷委託之原因係因被代理人於出具委託書時不具行為能力或不具委託權力或其他事由;逾期撤銷者,以委託代理人出席行使之表決權為準。

第五條、(召開地點及時間):

股東會應於董事會指定之時間及地點召開,惟除法令另有規定外,股東會應於中華民國境內召開。

如董事會決議在台灣境外召開股東會,相關程序及核准應依中華民國相關主管機關之規 定辦理。於中華民國境外召開股東會時,本公司應提供股東以書面投票或電子傳送方式 行使投票權之方法,並應於中華民國境內委託專業股務代理機構,受理該等股東會行政 事務(包括但不限於受理股東委託投票事宜)。

第六條、(文件備置):

本公司應於開會通知書載明受理股東報到時間、報到處地點,及其他應注意事項。 前項受理股東報到時間至少應於會議開始前三十分鐘辦理之;報到處應有明確標示,並 派適足適任人員辦理之。

股東本人或股東所委託之代理人(以下稱股東)應憑出席證、出席簽到卡或其他出席證件 出席股東會;屬徵求委託書之徵求人並應攜帶身分證明文件,以備核對。

本公司應設簽名簿供出席股東簽到,或由出席股東繳交簽到卡以代簽到。

本公司應將議事手冊、年報、出席證、發言條、表決票及其他會議資料,交付予出席股東會之股東;有選舉董事、監察人者,應另附選舉票。

政府或法人為股東時,出席股東會之代表人不限於一人。法人受託出席股東會時,僅得指派一人代表出席。

第七條、(股東會主席、列席人員):

股東會如由董事會召集者,其主席應由董事長擔任之,董事長請假或因故不能行使職權時,由副董事長代理之,無副董事長或副董事長亦請假或因故不能行使職權時,由董事長指定董事一人代理之,董事長未指定代理人或所指定之代理人因故不能行使代理職權時,應由其他出席之董事互推一人代理之。股東會如由董事會以外之其他召集權人召集者,主席由該召集權人擔任之,召集權人有二人以上時,應互推一人擔任之。

董事會所召集之股東會,宜有董事會過半數之董事參與出席。

本公司得指派所委任之律師、會計師或相關人員列席股東會。

第八條、(股東會法定出席股份數):

股東會之出席,應以股份為計算基準。出席股數依簽名簿或繳交之簽到卡,加計以書面或電子方式行使表決權之股數計算之。

已屆開會時間,主席應即宣布開會,惟除本公司章程另有規定及不違反公開發行公司法令之規定外,若於指定為股東會會議之時間開始時出席股東代表股份數未達法定出席股份數,或於股東會會議進行中出席股東代表股份數未達法定出席股份數者,主席得宣布延後開會,但其延後次數以二次為上限,且延後時間合計不得超過一小時。如股東會經延後二次開會但出席股東代表股份數仍不足法定出席股份數時,主席應宣布該股東會流會。如仍有召集股東會之必要者,則應依本公司章程規定重行召集一次新的股東會。

第九條、(議案討論):

股東會如由董事會召集者,其議程由董事會訂定之,會議應依排定之議程進行,非經股東會決議不得變更之。

於相關之股東名冊停止過戶期間前持有已發行股份總數百分之一以上股份之股東,得以書面向本公司提出一項股東常會議案,如(a)提案股東持股未達已發行股份總數百分之一;(b)該議案非股東會所得決議;(c)提案股東提案超過一項者;或(d)該提案於公告受理期間外提出者,提案不列入議程。

股東會如由董事會以外之其他有召集權人召集者,準用本條第一項之規定。

第一項及第三項排定之議程於議事(含臨時動議)未終結前,非經決議,主席不得逕行宣布散會;主席違反本規則,宣布散會者,董事會其他成員應迅速協助出席股東依法定程序,以出席股東表決權過半數之同意推選一人擔任主席,繼續開會。

股東會主席對於議案及股東所提之修正案或臨時動議,應給予充分說明及討論之機會,認為已達可付表決之程度時,得宣布停止討論,提付表決。

本公司應將股東會開會之過程全程錄音或錄影並保存影音資料應至少一年,遇有與股東會召集程序不當或不當通過決議有關之訴訟情事時,應保存至訴訟終結為止。前述之保存方式得以電子檔案形式為之。

第十條 (股東發言)

出席股東發言前,須先填具發言條載明發言要旨、股東戶號(或出席證編號)及戶名,由主席定其發言順序。

出席股東僅提發言條而未發言者,應視為該股東未發言。發言內容與發言條記載不符者,應以實際發言內容為準。

同一議案每一股東發言,非經主席之同意不得超過兩次,每次不得超過五分鐘,惟股東發言違反規定或超出議題範圍者,主席得制止其發言。

出席股東發言時,其他股東除經徵得主席及發言股東同意外,不得中斷該發言股東之發言,違反者主席應予制止。

法人股東指派二人以上之代表出席股東會時,同一議案僅得推由一人發言。

出席股東發言後,主席得親自或指定相關人員答覆。

第十一條 (表決股數之計算、迴避制度)

除章程另有規定外,股東會之表決依下述規定及第12條規定辦理。股東會之表決,應以 股份為計算基準。

股東會之決議,對依章程或法令規定無表決權股東之股份數,不算入已發行股份之總數。股東對於股東會討論之事項,有自身利害關係且其利益可能與本公司之利益衝突者,就其所持有的股份,不得在股東會上就該議案加入表決,並不得代理他股東行使其表決權。前項不得行使表決灌之股份數,不算入已出席股東之表決權數。但為計算法定出席股份數門檻之目的,此等股份仍應計入出席該股東會股東所代表之股份數。

除章程另有規定或章程或本規則所列無表決權者外,股東每股有一表決權。

除依據中華民國法律組織之信託事業或章程規定之公開發行公司規則核准之股務代理 機構外,一人同時受二人以上股東委託時,其代理之表決權不得超過股票停止過戶前本 公司已發行股份總數表決權之百分之三,超過時其超過之表決權,應不予計算。為避免 疑義,依章程規定由本公司委任之股務代理機構所代表之股份數應不受本公司已發行股 份總數表決權之百分之三之限制。

第十二條 (行使表決權及決議之方式)

股東每股有一表決權;但受限制或公司法第一百七十九條第二項所列無表決權者,不在此限。

本公司董事會得決定本公司召開股東會時,股東得以書面投票或電子方式行使其表決權;惟如表決權得以書面投票或電子方式行使時,表決權行使方法應載明於股東會召集通知。股東依前開規定以書面投票或電子方式行使其於股東會之表決權時,應視為親自出席該次股東會。但就該次股東會之臨時動議及/或原議案之修正,此等股東無權受通知以及無權行使表決權。為避免疑義,以此種方式行使表決權之股東應視為已拋棄其就該次股東會之臨時動議及/或原議案之修正之通知及表決權之權利。

前項以書面投票或電子方式行使表決權之股東,其意思表示應於股東會開會二日前送達公司,同一股東有超過一個之表示時,以最先送達者為準。但該股東較晚送達之表示有明確之書面聲明撤銷前表示者,不在此限。

股東依前項規定將其以書面投票或電子方式行使表決權之意思表示送達公司後,嗣後如欲親自出席股東會者,應於股東會開會二日前以與行使表決權相同之方式撤銷前項行使表決權之意思表示。逾期撤銷意思表示者,以書面投票或電子方式行使之表決權為準。如以書面投票或電子方式行使表決權並以委託書委託代理人出席股東會者,以委託代理人出席行使之表決權為準。

除章程或本規則另有規定外,議案之表決應依出席股東表決權數過半數之同意通過之。 表決時,應逐案由主席或其指定人員宣佈出席股東之表決權總數。

同一議案有修正案或替代案時,由主席併同原案定其表決之順序。如其中一案已獲通過 時,其他議案即視為否決,勿庸再行表決。

議案表決之監票及計票人員,由主席指定之,但監票人員應具有股東身分。

股東會表決或選舉議案之計票作業應於股東會場內公開處為之,且應於計票完成後,當場宣布表決結果,包含統計之權數,並作成紀錄。

第十三條 (選舉或解任事項)

股東會有選舉或解任董事時,應依本公司章程辦理,並應當場宣布選舉或解任結果。 前項選舉或解任之選舉或表決票,應由監票人及主席密封簽字後至少保存一年,遇有與 股東會召集程序不當或不當通過決議有關之訴訟情事時,應保存至訴訟終結為止。

第十四條 (股東會議事錄)

股東會之議決事項,應作成議事錄,由主席簽名或蓋章,並於會後二十日內,將議事錄分發各股東。議事錄之製作及分發,得以電子方式為之。

前項議事錄之分發,本公司得以公告方式為之。

議事錄應確實依會議之日期(年、月、日)、場所、主席姓名、決議方法、議事經過之要領及其結果記載之,並應保存至少一年,遇有與股東會召集程序不當或不當通過決議有關之訴訟情事時,應保存至訴訟終結為止。

第十五條 (會場秩序之維護)

辦理股東會之會務人員應佩帶識別證或臂章。

股東會得設置糾察員或保全人員並由主席指揮協助維持會場秩序。糾察員或保全人員在場協助維持秩序時,應佩戴「糾察員」字樣臂章或識別證。

會場備有擴音設備者,股東非以本公司配置之設備發言時,主席得制止之。

股東(a)違反本規則不服從主席糾正,或(b)妨礙會議之進行經制止不從者,得由主席指揮糾察員或保全人員請其離開會場。

第十六條 (休息、續行集會)

會議進行時,主席得酌定時間宣布休息,發生不可抗拒之情事時,主席得裁定暫時停止 會議,並視情況宣布續行開會之時間。

股東會排定之議程於議事(含臨時動議)未終結前,開會之場地屆時未能繼續使用,得由股東會決議另覓場地繼續開會。

第十七條 (訂定和修訂程序)

本規則應於本公司向臺灣證券交易所(或證券櫃檯買賣中心)或其他相關主管機關提出申請股票第一上市(或興櫃股票櫃檯買賣)或申報辦理公開發行時起(以孰早者為準)自動生效,其修正應經股東會通過。惟,依相關法令辦理申報公告事宜,於本公司股票於臺灣證券交易所(或證券櫃檯買賣中心)正式上市掛牌交易(或興櫃股票櫃檯買賣)或於台灣公開發行時起(以孰早者為準),始適用之。

第十八條 (法令變動)

如有與本規則所訂事項相關之中華民國法令有所變動,該新修正之法令應優先於本規則 相關條款之適用,且本公司應依該新修正之法令修改本規則,並將該修正案提交下次股 東會通過。

茂林光電科技(開曼)股份有限公司 民國一一〇年度營業報告書

110年全球面臨後疫情時代的新一波挑戰,缺工、缺料、運輸等問題,衝擊 供應鏈的運作,茂林光電營運亦受到些許影響,但公司同仁還是積極地面對接 踵而來的挑戰,將影響降到最低。

茂林光電 110 年度合併營業收入為新台幣 109 億元,合併營業毛利為新台幣 21.5 億元;合併稅後淨利為新台幣 12.8 億元,每股稅後盈餘為新台幣 9.74 元。茲將 110 年營業表現及 111 年度的營業計劃概要報告如下:

一、110年度合併營業表現:

二、業務及研發成果:

110年全球筆電出貨量創歷史新高,雖然疫情所衍生宅經濟效應的需求減退,但受惠歐美企業陸續回歸辦公室,帶動商用換機潮,伴隨下半年新機種量產,IT產品出貨量較 109 年成長。

液晶電視、顯示器及穿戴產品,受供應鏈缺料及運輸問題衝擊較大,物料安排導致新機種量產時間遞延,出貨量較109年衰退。

公司持續推廣導光板在各種不同產品的應用,車用產品及消費性產品隨 著新機種陸續量產,因產品壽命週期長,維持穩定的成長趨勢。

茂林光電同步投入產品研發及製程研發,110年投入了新台幣 2.0 億元研發費用以及新台幣 2.3 億元資本支出,擴大導光板應用的產品類別,更藉由製程的優勢將導光板與其他模組材料結合,提供客戶模組化的解決方案,致力於提升客戶滿意度及企業永續成長的核心價值。

三、111年度營業計劃概要:

茂林光電將堅守穩定成長的經營策略,在現有產品上持續深耕,以光學 及製程的核心技術,提供客戶更具競爭力的產品,同時不斷的拓展各種產品 應用,主要重點方向為:

1. 持續強化智能製造之設備及生產流程,落實製程技術升級之目標。

- 2. 順應 Micro LED、Mini LED 等新一代的光源技術,開發相關的產品應用。
- 3. 透過跨國技術合作的模式,研發更具競爭力的產品,擴大公司產品領域。

四、未來展望:

全球經濟可望在各國新的防疫政策下,逐步恢復到新的常態,供應鏈也 將調整到更符合新常態的需求,茂林光電將以技術創新,積極拓展導光應 用,並以製程創新提升產品的整合價值,與供應鏈夥伴創造雙贏。

氣候環境議題、全球性通膨壓力、政經局勢的變化,將使公司的營運面對更多的挑戰,公司將以全球化的佈局以及穩健經營的精神,持續追求穩定的成長。

會計師查核報告

Global Lighting Technologies Inc. 公鑒:

查核意見

Global Lighting Technologies Inc.及其子公司(茂林集團)民國 110年及 109年 12月 31日之合併資產負債表,暨民國 110年及 109年 1月1日至 12月 31日之合併綜合損益表、合併權益變動表與合併現金流量表,以及合併財務報表附註(包括重大會計政策彙總),業經本會計師查核竣事。

依本會計師之意見,上開合併財務報表在所有重大方面係依照證券發行人財務報告編製準則及經金融監督管理委員會認可並發布生效之國際財務報導準則、國際會計準則、解釋及解釋公告編製,足以允當表達茂林集團民國110年及109年12月31日之合併財務狀況,暨民國110年及109年1月1日至12月31日之合併財務績效及合併現金流量。

查核意見之基礎

本會計師係依照會計師查核簽證財務報表規則及一般公認審計準則執行查核工作。本會計師於該等準則下之責任將於會計師查核合併財務報表之責任段進一步說明。本會計師所隸屬事務所受獨立性規範之人員已依會計師職業道德規範,與茂林集團保持超然獨立,並履行該規範之其他責任。本會計師相信已取得足夠及適切之查核證據,以作為表示查核意見之基礎。

關鍵查核事項

關鍵查核事項係指依本會計師之專業判斷,對茂林集團民國 110 年度合併財務報表之查核最為重要之事項。該等事項已於查核合併財務報表整體及 形成查核意見之過程中予以因應,本會計師並不對該等事項單獨表示意見。

兹對茂林集團民國 110 年度合併財務報表之關鍵查核事項敘明如下:

特定客戶銷貨收入發生之真實性

由於茂林集團為上市公司,故預期管理階層有達成預計財務目標之壓力,其中營業收入係判斷獲利能力及經營績效的重要指標之一,且收入認列具有先天上較高之風險,茂林集團民國 110 年度特定客戶銷貨收入 3,390,184 仟元,佔合併營業收入約 31%,較民國 109 年度特定客戶銷貨收入大幅增加,對合併財務報表之影響係屬重大,故本會計師認為主要風險在於特定客戶銷貨收入發生之真實性,而將其列入本年度合併財務報表之關鍵查核事項。

有關收入認列會計政策,請參閱合併財務報告附註四;營業收入相關說明請參閱合併財務報告附註二一。本會計師對上述所述關鍵查核事項已執行之主要查核程序如下:

- 了解上述特定客戶銷貨交易相關之內部控制制度,並評估其設計與執行 之有效性。
- 執行上述特定客戶其本年度收入交易之證實性測試,選取適當樣本至外 部交易文件及貨款收回情形,用以驗證交易真實發生及收款情況是否未 有重大異常。
- 另檢視於資產負債表日以後是否發生重大銷貨退回情形,俾確認收入認 列有無重大異常。

管理階層與治理單位對合併財務報表之責任

管理階層之責任係依照證券發行人財務報告編製準則及經金融監督管理 委員會認可並發布生效之國際財務報導準則、國際會計準則、解釋及解釋公 告編製允當表達之合併財務報表,且維持與合併財務報表編製有關之必要內 部控制,以確保合併財務報表未存有導因於舞弊或錯誤之重大不實表達。

於編製合併財務報表時,管理階層之責任亦包括評估茂林集團繼續經營之能力、相關事項之揭露,以及繼續經營會計基礎之採用,除非管理階層意圖清算茂林集團或停止營業,或除清算或停業外別無實際可行之其他方案。

茂林集團之治理單位(含審計委員會)負有監督財務報導流程之責任。

會計師查核合併財務報表之責任

本會計師查核合併財務報表之目的,係對合併財務報表整體是否存有導因於舞弊或錯誤之重大不實表達取得合理確信,並出具查核報告。合理確信係高度確信,惟依照一般公認審計準則執行之查核工作無法保證必能偵出合

併財務報表存有之重大不實表達。不實表達可能導因於舞弊或錯誤。如不實 表達之個別金額或彙總數可合理預期將影響合併財務報表使用者所作之經濟 決策,則被認為具有重大性。

本會計師依照一般公認審計準則查核時,運用專業判斷並保持專業上之懷疑。本會計師亦執行下列工作:

- 1. 辨認並評估合併財務報表導因於舞弊或錯誤之重大不實表達風險;對所評估之風險設計及執行適當之因應對策;並取得足夠及適切之查核證據以作為查核意見之基礎。因舞弊可能涉及共謀、偽造、故意遺漏、不實聲明或踰越內部控制,故未偵出導因於舞弊之重大不實表達之風險高於導因於錯誤者。
- 對與查核攸關之內部控制取得必要之瞭解,以設計當時情況下適當之查 核程序,惟其目的非對茂林集團內部控制之有效性表示意見。
- 3. 評估管理階層所採用會計政策之適當性,及其所作會計估計與相關揭露 之合理性。
- 4. 依據所取得之查核證據,對管理階層採用繼續經營會計基礎之適當性,以及使茂林集團繼續經營之能力可能產生重大疑慮之事件或情況是否存在重大不確定性,作出結論。本會計師若認為該等事件或情況存在重大不確定性,則須於查核報告中提醒合併財務報表使用者注意合併財務報表之相關揭露,或於該等揭露係屬不適當時修正查核意見。本會計師之結論係以截至查核報告日所取得之查核證據為基礎。惟未來事件或情況可能導致茂林集團不再具有繼續經營之能力。
- 評估合併財務報表(包括相關附註)之整體表達、結構及內容,以及合併財務報表是否允當表達相關交易及事件。
- 6. 對於集團內組成個體之財務資訊取得足夠及適切之查核證據,以對合併 財務報表表示意見。本會計師負責集團查核案件之指導、監督及執行, 並負責形成集團查核意見。

本會計師與治理單位溝通之事項,包括所規劃之查核範圍及時間,以及重大查核發現(包括於查核過程中所辨認之內部控制顯著缺失)。

本會計師亦向治理單位提供本會計師所隸屬事務所受獨立性規範之人員已遵循會計師職業道德規範中有關獨立性之聲明,並與治理單位溝通所有可能被認為會影響會計師獨立性之關係及其他事項(包括相關防護措施)。

本會計師從與治理單位溝通之事項中,決定對茂林集團民國 110 年度合併財務報表查核之關鍵查核事項。本會計師於查核報告中敘明該等事項,除非法令不允許公開揭露特定事項,或在極罕見情況下,本會計師決定不於查核報告中溝通特定事項,因可合理預期此溝通所產生之負面影響大於所增進之公眾利益。

The rules and procedures of the audit committee shall be in accordance with policies proposed by the members of the audit committee and passed by the Directors from time to time, which shall be in accordance with the Statute, the Memorandum, the Articles and the Applicable Public Company Rules and the instruction of the FSC or TWSE, if any. If in a winding up the assets available for distribution amongst the Members shall be more than sufficient to repay the whole of the share capital at the commencement of the winding up, the surplus shall be distributed amongst the Members in proportion to the number of the Shares held by them at the commencement of the winding up subject to a deduction from those Shares in respect of which there are monies due, of all monies payable to the Company. - 3.5. 選舉票由董事會製備,選舉人之記名得以在選票上所印出席證號碼代之,並加填其 權數。
- 3.6. 被選舉人如為股東身分者,選舉人在選舉票「被選舉人」欄須填明被選舉人戶名及 被選舉人股東戶號;如非股東身分者,應填明被選舉人姓名及身分證明文件編號。
- 3.7. 前項被選舉人如為法人股東時,應書明法人名稱,其為法人之代表人時,應同時書明法人之名稱及代表人之姓名,代表人有數人時,應分別填列該法人名稱及代表人姓名。
- 3.8. 選舉票有下列情形之一者無效:
 - **3.8.1.** 不用第3.5條規定之選票者。
 - 3.8.2. 所填被選舉人數超過應選名額者。
 - 3.8.3. 除被選舉人姓名(戶名)、戶號或身分證明文件編號外,夾寫其他文字者。

- 3.10. 當選董事由董事會分別發給當選通知書。

 - 3.11.1 本辦法於本公司向臺灣證券交易所(或證券櫃檯買賣中心)或其他相關主管機關提出申請股票第一上市(或興櫃股票櫃檯買賣)或申報辦理公開發行時起(以孰早者為準)自動生效。惟,依相關法令辦理申報公告事宜,於本公司股票於臺灣證券交易所(或證券櫃檯買賣中心)正式上市掛牌交易(或興櫃股票櫃檯買賣)或於台灣公開發行時起(以孰早者為準),始適用之。
 - 3.11.2 本辦法於董事會決議通過後,送股東會通過決議,修改時亦同。倘中華民國 法令就本辦法所訂事項有所變動,該新修正之法令應取代本辦法中之相關規 定,本辦法應適時配合修改,並應依照法令經董事會及股東會決議通過。
