茂林光電科技(開曼)股份有限公司 民國一一三年度營業報告書

113 年全球經濟環境因各國的貨幣政策、地緣政治風險的影響,造成經濟成長放緩,面對複雜多變的經濟環境,公司同仁持續保持與現有客戶的密切合作,並積極耕耘新市場、新應用,確保公司能在穩定經營中追求長期的成長。

一、113年度合併營業表現

茂林光電 113 年度合併營業收入為新台幣 69.46 億元,合併營業毛利為新台幣 10.85 億元;合併稅後淨利為新台幣 5.29 億元,每股稅後盈餘為新台幣 4.10 元,獲利較 112 年度成長。

二、業務及研發成果

儘管 113 年全球經濟環境充滿挑戰,公司近年耕耘的市場與產品需求仍有小幅回升的跡象,讓營收與獲利都較 112 成長。

為強化全球製造布局,公司於 113 年度啟動越南建廠計畫,越南新廠將於 114 年中建置 完成。公司亦計劃在泰國設立新的製造據點,未來能夠提供客戶更多不同製造地點的服務。

在研發方面,茂林光電持續強化光學設計與精密製造的核心競爭力,並根據產業發展趨勢,提升軟、硬體各方面的建置,於113年公司投入新台幣2.5億元的研發經費及新台幣5.8億元的資本支出,進一步提升競爭優勢。藉由精密製造的技術,113年開始進入生技醫療市場,實現擴大產品線的目標。

茂林光電將繼續專注於產品研發、智能製造及製程自動化,積極投入前瞻性技術的研究,並以模組化設計提升產品的附加價值,提供客戶更完整的產品解決方案。

三、114年度營業計畫概要

茂林光電密切關注經濟環境與消費市場的變化,以現有技術持續開發新客戶、新產品, 並積極將技術延伸至其他領域的應用,降低對單一區域或市場的依賴與風險,主要重點方向 為:

- 1. 藉由投資與策略合作,開發新的產品應用領域。
- 2. 強化模組設計與製造的能力,銷售高附加價值的模組產品。
- 3. 積極導入智能化、自動化生產,配合未來全球製造佈局。
- 4. 持續優化銷售產品結構,提升公司獲利能力。

四、公司未來展望、外部競爭環境及總體經營環境之影響

面對經濟環境不確定性、地緣政治衝突及極端氣候對供應鏈的衝擊,公司將持續堅持穩 健的經營策略,專注於提升核心技術與拓展產品應用範疇,在產品設計與生產過程中,強化 循環經濟與節能減碳的理念,積極響應市場對環保與創新科技的需求。

查核意見

Global Lighting Technologies Inc.及其子公司(茂林集團)民國 113年及 112年 12月 31日之合併資產負債表,暨民國 113年及 112年 1月1日至12月 31日之合併綜合損益表、合併權益變動表與合併現金流量表,以及合併財務報表附註(包括重大會計政策彙總),業經本會計師查核竣事。

依本會計師之意見,上開合併財務報表在所有重大方面係依照中華民國證券發行人財務報告編製準則及經金融監督管理委員會認可並發布生效之國際財務報導準則、國際會計準則、解釋及解釋公告編製,足以允當表達茂林集團民國 113 年及 112 年 12 月 31 日之合併財務狀況,暨民國 113 年及 112年 1 月 1 日至 12 月 31 日之合併財務績效及合併現金流量。

查核意見之基礎

本會計師係依照中華民國會計師受託查核簽證財務報表規則及審計準則 執行查核工作。本會計師於該等準則下之責任將於會計師查核合併財務報表 之責任段進一步說明。本會計師所隸屬事務所受獨立性規範之人員已依會計 師職業道德規範,與茂林集團保持超然獨立,並履行該規範之其他責任。本 會計師相信已取得足夠及適切之查核證據,以作為表示查核意見之基礎。 關

鍵查核事項

關鍵查核事項係指依本會計師之專業判斷,對茂林集團民國 113 年度合併財務報表之查核最為重要之事項。該等事項已於查核合併財務報表整體及 形成查核意見之過程中予以因應,本會計師並不對該等事項單獨表示意見。 茲對茂林集團民國 113 年度合併財務報表之關鍵查核事項敘明如下: 特定客戶銷貨收入發生之真實性

由於茂林集團為上市公司,故預期管理階層有達成預計財務目標之壓力,其中營業收入係判斷獲利能力及經營績效的重要指標之一,且收入認列具有先天上較高之風險,茂林集團民國 113 年度特定客戶銷貨收入 1,640,034 仟元,佔合併營業收入約 24%,對合併財務報表之影響係屬重大,故本會計師認為主要風險在於特定客戶銷貨收入發生之真實性,而將其列入本年度合併財務報表之關鍵查核事項。

有關收入認列會計政策,請參閱合併財務報告附註四;營業收入相關說明請參閱合併財務報告附註二十。本會計師對上述所述關鍵查核事項已執行之主要查核程序如下:

- 了解上述特定客戶銷貨交易相關之內部控制制度,並評估其設計與執行 之有效性。
- 2. 執行上述特定客戶其本年度收入交易之證實性測試,選取適當樣本抽核至外部交易文件及貨款收回情形,用以驗證交易真實發生及收款情況是否未有重大異常。

管理階層與治理單位對合併財務報表之責任

管理階層之責任係依照中華民國證券發行人財務報告編製準則及經金融監督管理委員會認可並發布生效之國際財務報導準則、國際會計準則、解釋及解釋公告編製允當表達之合併財務報表,且維持與合併財務報表編製有關之必要內部控制,以確保合併財務報表未存有導因於舞弊或錯誤之重大不實表達。

於編製合併財務報表時,管理階層之責任亦包括評估茂林集團繼續經營之能力、相關事項之揭露,以及繼續經營會計基礎之採用,除非管理階層意圖清算茂林集團或停止營業,或除清算或停業外別無實際可行之其他方案。

茂林集團之治理單位(含審計委員會)負有監督財務報導流程之責任。

會計師查核合併財務報表之責任

本會計師查核合併財務報表之目的,係對合併財務報表整體是否存有導因於舞弊或錯誤之重大不實表達取得合理確信,並出具查核報告。合理確信係高度確信,惟依照審計準則執行之查核工作無法保證必能偵出合併財務報

表存有之重大不實表達。不實表達可能導因於舞弊或錯誤。如不實表達之個別金額或彙總數可合理預期將影響合併財務報表使用者所作之經濟決策,則被認為具有重大性。

本會計師依照審計準則查核時,運用專業判斷及專業懷疑。本會計師亦執行下列工作:

- 1. 辨認並評估合併財務報表導因於舞弊或錯誤之重大不實表達風險;對所評估之風險設計及執行適當之因應對策;並取得足夠及適切之查核證據以作為查核意見之基礎。因舞弊可能涉及共謀、偽造、故意遺漏、不實聲明或踰越內部控制,故未偵出導因於舞弊之重大不實表達之風險高於導因於錯誤者。
- 對與查核攸關之內部控制取得必要之瞭解,以設計當時情況下適當之查 核程序,惟其目的非對茂林集團內部控制之有效性表示意見。
- 3. 評估管理階層所採用會計政策之適當性,及其所作會計估計與相關揭露 之合理性。
- 4. 依據所取得之查核證據,對管理階層採用繼續經營會計基礎之適當性,以及使茂林集團繼續經營之能力可能產生重大疑慮之事件或情況是否存在重大不確定性,作出結論。本會計師若認為該等事件或情況存在重大不確定性,則須於查核報告中提醒合併財務報表使用者注意合併財務報表之相關揭露,或於該等揭露係屬不適當時修正查核意見。本會計師之結論係以截至查核報告日所取得之查核證據為基礎。惟未來事件或情況可能導致茂林集團不再具有繼續經營之能力。
- 評估合併財務報表(包括相關附註)之整體表達、結構及內容,以及合併財務報表是否允當表達相關交易及事件。
- 6. 對於集團內組成個體之財務資訊取得足夠及適切之查核證據,以對合併 財務報表表示意見。本會計師負責集團查核案件之指導、監督及執行, 並負責形成集團查核意見。

本會計師亦向治理單位提供本會計師所隸屬事務所受獨立性規範之人員 已遵循中華民國會計師職業道德規範中有關獨立性之聲明,並與治理單位溝 通所有可能被認為會影響會計師獨立性之關係及其他事項(包括相關防護措 施)。

本會計師從與治理單位溝通之事項中,決定對茂林集團民國 113 年度合併財務報表查核之關鍵查核事項。本會計師於查核報告中敘明該等事項,除非法令不允許公開揭露特定事項,或在極罕見情況下,本會計師決定不於查核報告中溝通特定事項,因可合理預期此溝通所產生之負面影響大於所增進之公眾利益。

肆、附錄

一、股東會議事規則

第一條、(前言):

為建立本公司良好股東會治理制度、健全監督功能及強化管理機能,爰訂定本股東會議事規則(下稱「本規則」),以資遵循。

第二條、(總則):

除相關法令或本公司章程大綱及公司章程(下稱「章程」)另有規定者外,本公司股東會議事應依本規則之規定。

所有於本規則中使用但未加以明確定義之用語,均與其在章程中之意義相同。

第三條、(股東會之召集及通知程序):

本公司股東會除法令或章程另有規定外,由董事會召集之。

本公司股東會召開方式之變更應經董事會決議,並最遲於股東會開會通知書寄發前為之。 董事會經繼續一年以上持有已發行股份總數百分之三以上股份之股東依章程規定請求董 事會召集股東臨時會而於股東提出請求日起十五日內未為股東臨時會召集之通知時,提 出請求之股東得依據公開發行公司法令,自行召集股東臨時會。繼續三個月以上持有已 發行股份總數過半數股份之股東,得自行召集股東臨時會。股東持股期間及持股數之計 算,以停止股票過戶時之持股為準。

股東會之召集,應編製議事手冊,並依相關法令和章程規定之時間與方式,於股東會十五日前將議事手冊及其他相關資料於中華民國證券主管機關指定之公開資訊觀測站公告申報之。但本公司於最近會計年度終了日實收資本額達新臺幣一百億元以上或最近會計年度召開股東常會其股東名簿記載之外資及陸資持股比率合計達百分之三十以上者,應於股東常會開會三十日前完成前開電子檔案之傳送。

前項之議事手冊及會議補充資料,本公司於股東會開會當日應依下列方式提供股東參閱: 一、召開實體股東會時,應於股東會現場發放。

二、召開視訊輔助股東會時,應於股東會現場發放,並以電子檔案傳送至視訊會議平台。 三、召開視訊股東會時,應以電子檔案傳送至視訊會議平台。

股東會召集之通知,常會應於開會日之三十日前通知各股東,臨時會應於十五日前通知各股東。

通知及公告應載明召集事由;其通知經股東事前同意者,得以電子方式為之。

與下列有關之事項應載明於股東會通知並說明其主要內容,且不得以臨時動議提出,其主要內容得置於中華民國證券主管機關或本公司指定之網站,並將其網址載明於召集通知:

- 一、選舉或解任董事;
- 二、修改章程;
- 三、減資;
- 四、申請停止公開發行;
- 五、解散、合併、股份轉換、分割;

六、訂立、修改或終止關於出租本公司全部營業,或委託經營,或與他人經常共同經營 之契約;

七、讓與本公司全部或主要部份之營業或財產;

八、受讓他人全部營業或財產而對本公司營運有重大影響者;

九、許可董事為其自己或他人從事本公司營業範圍內事務之行為;

十、以發行新股方式分配本公司全部或部分盈餘;

十一、將法定盈餘公積及因發行股票溢價或受領贈與所得之資本公積,以發行新股或現 金方式分配與原股東;

十二、本公司私募發行具股權性質之有價證券。

第四條、(委託書):

股東得依據本公司章程以本公司核准之格式之委託書,載明授權範圍,委託代理人,出席股東會,並載明該委託書僅為特定股東會所為。

委託書格式內容應至少包括填表須知、股東委託行使事項及股東、受託代理人及徵求人 (若有)基本資料等項目,委託書用紙並應與股東會召集通知同時提供予股東,並應於 同日分發予所有股東。

一股東以出具一委託書,並以委託一人為限,應於股東會開會五日前送達本公司登記處所或送達股東會召集通知或本公司寄出之委託書上所指定之處所,委託書有重複時,以最先送達者為準。但股東在後送達的文件中明確以書面聲明撤銷前委託者,不在此限。委託書送達本公司後,股東欲親自出席股東會者,應於股東會開會二日前,以書面向本公司為撤銷委託之通知,該通知應敘明撤銷委託之原因係因被代理人於出具委託書時不具行為能力或不具委託權力或其他事由;逾期撤銷者,以委託代理人出席行使之表決權為準。

委託書送達本公司後,股東欲以視訊方式出席股東會,應於股東會開會二日前,以書面向本公司為撤銷委託之通知;逾期撤銷者,以委託代理人出席行使之表決權為準。

第五條、(召開地點及時間):

股東會應於董事會指定之時間及地點召開,惟除法令另有規定外,股東會應於中華民國境內召開。

如董事會決議在台灣境外召開股東會,相關程序及核准應依中華民國相關主管機關之規 定辦理。於中華民國境外召開股東會時,本公司應提供股東以書面投票或電子傳送方式 行使投票權之方法,並應於中華民國境內委託專業股務代理機構,受理該等股東會行政 事務(包括但不限於受理股東委託投票事宜)。

本公司召開視訊股東會時,不受前項召開地點之限制。

第六條、(文件備置):

本公司應於開會通知書載明受理股東報到時間、報到處地點,及其他應注意事項。 前項受理股東報到時間至少應於會議開始前三十分鐘辦理之;報到處應有明確標示,並 派適足適任人員辦理之;股東會視訊會議應於會議開始前三十分鐘,於股東會視訊會議 平台受理報到,完成報到之股東,視為親自出席股東會。 股東本人或股東所委託之代理人(以下稱股東)應憑出席證、出席簽到卡或其他出席證件出席股東會;屬徵求委託書之徵求人並應攜帶身分證明文件,以備核對。

本公司應設簽名簿供出席股東簽到,或由出席股東繳交簽到卡以代簽到。

本公司應將議事手冊、年報、出席證、發言條、表決票及其他會議資料,交付予出席股東會之股東;有選舉董事、監察人者,應另附選舉票。

政府或法人為股東時,出席股東會之代表人不限於一人。法人受託出席股東會時,僅得指派一人代表出席。

股東會以視訊會議召開者,股東欲以視訊方式出席者,應於股東會開會二日前,向本公司登記。

股東會以視訊會議召開者,本公司至少應於會議開始前三十分鐘,將議事手冊、年報及其他相關資料上傳至股東會視訊會議平台,並持續揭露至會議結束。

第六條之一、(召開股東會視訊會議,召集通知應記載事項):

本公司召開股東會視訊會議,應於股東會召集通知載明下列事項:

- 一、股東參與視訊會議及行使權利方法。
- 二、因天災、事變或其他不可抗力情事致視訊會議平台或以視訊方式參與發生障礙之處 理方式,至少包括下列事項:
- (一)發生前開障礙持續無法排除致須延期或續行會議之時間,及如須延期或續行集會時 之日期。
- (二)未登記以視訊參與原股東會之股東不得參與延期或續行會議。
- (三)召開視訊輔助股東會,如無法續行視訊會議,經扣除以視訊方式參與股東會之出席 股數,出席股份總數達股東會開會之法定定額,股東會應繼續進行,以視訊方式參 與股東,其出席股數應計入出席之股東股份總數,就該次股東會全部議案,視為棄 權。
- (四)遇有全部議案已宣布結果,而未進行臨時動議之情形,其處理方式。

第七條、(股東會主席、列席人員):

股東會如由董事會召集者,其主席應由董事長擔任之,董事長請假或因故不能行使職權時,由副董事長代理之,無副董事長或副董事長亦請假或因故不能行使職權時,由董事長指定董事一人代理之,董事長未指定代理人或所指定之代理人因故不能行使代理職權時,應由其他出席之董事互推一人代理之。股東會如由董事會以外之其他召集權人召集者,主席由該召集權人擔任之,召集權人有二人以上時,應互推一人擔任之。

董事會所召集之股東會,宜有董事會過半數之董事參與出席。

本公司得指派所委任之律師、會計師或相關人員列席股東會。

第八條、(股東會法定出席股份數):

股東會之出席,應以股份為計算基準。出席股數依簽名簿或繳交之簽到卡及視訊會議平 台報到股數,加計以書面或電子方式行使表決權之股數計算之。

已屆開會時間,主席應即宣布開會,惟除本公司章程另有規定及不違反公開發行公司法令之規定外,若於指定為股東會會議之時間開始時出席股東代表股份數未達法定出席股份數,或於股東會會議進行中出席股東代表股份數未達法定出席股份數者,主席得宣布延後開會,但其延後次數以二次為上限,且延後時間合計不得超過一小時。如股東會經

延後二次開會但出席股東代表股份數仍不足法定出席股份數時,主席應宣布該股東會流會;股東會以視訊會議召開者,本公司另應於股東會視訊會議平台公告流會。

如仍有召集股東會之必要者,則應依本公司章程規定重行召集一次新的股東會;股東會以視訊會議召開者,股東欲以視訊方式出席者,應依第六條向本公司重行登記。

第九條、(議案討論):

股東會如由董事會召集者,其議程由董事會訂定之,會議應依排定之議程進行,非經股東會決議不得變更之。

於相關之股東名冊停止過戶期間前持有已發行股份總數百分之一以上股份之股東,得以書面或電子受理方式向本公司提出股東常會議案,除有下列情形之一者外,董事會應將股東之提案列為議案:(a)提案股東持股未達已發行股份總數百分之一;(b)該議案非股東會所得決議;(c)提案股東提案超過一項者;或(d)該提案於公告受理期間外提出者。依公開發行公司法令之規定,股東提案係為敦促本公司增進公共利益或善盡社會責任之建議者,董事會得列入議案。

股東會如由董事會以外之其他有召集權人召集者,準用本條第一項之規定。

第一項及第三項排定之議程於議事(含臨時動議)未終結前,非經決議,主席不得逕行宣布散會;主席違反本規則,宣布散會者,董事會其他成員應迅速協助出席股東依法定程序,以出席股東表決權過半數之同意推選一人擔任主席,繼續開會。

股東會主席對於議案及股東所提之修正案或臨時動議,應給予充分說明及討論之機會,認為已達可付表決之程度時,得宣布停止討論,提付表決。

第十條 (股東發言)

出席股東發言前,須先填具發言條載明發言要旨、股東戶號(或出席證編號)及戶名,由主席定其發言順序。

出席股東僅提發言條而未發言者,應視為該股東未發言。發言內容與發言條記載不符者, 應以實際發言內容為準。

同一議案每一股東發言,非經主席之同意不得超過兩次,每次不得超過五分鐘,惟股東 發言違反規定或超出議題範圍者,主席得制止其發言。

出席股東發言時,其他股東除經徵得主席及發言股東同意外,不得中斷該發言股東之發言,違反者主席應予制止。

出席股東發言後,主席得親自或指定相關人員答覆。

股東會以視訊會議召開者,以視訊方式參與之股東,得於主席宣布開會後,至宣布散會前,於股東會視訊會議平台以文字方式提問,每一議案提問次數不得超過兩次,每次以 二百字為限。

第十一條 (表決股數之計算、迴避制度)

除章程另有規定外,股東會之表決依下述規定及第12條規定辦理。股東會之表決,應以 股份為計算基準。

股東會之決議,對依章程或法令規定無表決權股東之股份數,不算入已發行股份之總數。 股東對於股東會討論之事項,有自身利害關係且其利益可能與本公司之利益衝突者,就 其所持有的股份,不得在股東會上就該議案加入表決,並不得代理他股東行使其表決權。 前項不得行使表決灌之股份數,不算入已出席股東之表決權數。但為計算法定出席股份 數門檻之目的,此等股份仍應計入出席該股東會股東所代表之股份數。

股東依前項規定將其以書面投票或電子方式行使表決權之意思表示送達公司後,嗣後如欲親自或以視訊方式出席股東會者,應於股東會開會二日前以與行使表決權相同之方式撤銷前項行使表決權之意思表示。逾期撤銷意思表示者,以書面投票或電子方式行使之表決權為準。如以書面投票或電子方式行使表決權並以委託書委託代理人出席股東會者,以委託代理人出席行使之表決權為準。

除章程或本規則另有規定外,議案之表決應依出席股東表決權數過半數之同意通過之。 表決時,應逐案由主席或其指定人員宣佈出席股東之表決權總數。

同一議案有修正案或替代案時,由主席併同原案定其表決之順序。如其中一案已獲通過 時,其他議案即視為否決,勿庸再行表決。

議案表決之監票及計票人員,由主席指定之,但監票人員應具有股東身分。

股東會表決或選舉議案之計票作業應於股東會場內公開處為之,且應於計票完成後,當場宣布表決結果,包含統計之權數,並作成紀錄。

本公司召開股東會視訊會議,以視訊方式參與之股東,於主席宣布開會後,應透過視訊會議平台進行各項議案表決及選舉議案之投票,並應於主席宣布投票結束前完成,逾時者視為棄權。

股東會以視訊會議召開者,應於主席宣布投票結束後,為一次性計票,並宣布表決及選舉結果。

本公司召開視訊輔助股東會時,已依第六條規定登記以視訊方式出席股東會之股東,欲 親自出席實體股東會者,應於股東會開會二日前,以與登記相同之方式撤銷登記;逾期 撤銷者,僅得以視訊方式出席股東會。

以書面或電子方式行使表決權,未撤銷其意思表示,並以視訊方式參與股東會者,除臨 時動議外,不得再就原議案行使表決權或對原議案提出修正或對原議案之修正行使表決 權。

第十三條 (選舉或解任事項)

股東會有選舉或解任董事時,應依本公司章程辦理,並應當場宣布選舉或解任結果。 前項選舉或解任之選舉或表決票,應由監票人及主席密封簽字後至少保存一年,遇有與 股東會召集程序不當或不當通過決議有關之訴訟情事時,應保存至訴訟終結為止。

第十四條 (股東會議事錄)

股東會之議決事項,應作成議事錄,由主席簽名或蓋章,並於會後二十日內,將議事錄分發各股東。議事錄之製作及分發,得以電子方式為之。

前項議事錄之分發,本公司得以公告方式為之。

議事錄應確實依會議之日期(年、月、日)、場所、主席姓名、決議方法、議事經過之 要領及其結果記載之,並應保存至少一年,遇有與股東會召集程序不當或不當通過決議 有關之訴訟情事時,應保存至訴訟終結為止。

股東會以視訊會議召開者,其議事錄除依前項規定應記載事項外,並應記載股東會之開會起迄時間、會議之召開方式、主席及紀錄之姓名,及因天災、事變或其他不可抗力情事致視訊會議平台或以視訊方式參與發生障礙時之處理方式及處理情形。

第十五條 (會場秩序之維護)

辦理股東會之會務人員應佩帶識別證或臂章。

股東會得設置糾察員或保全人員並由主席指揮協助維持會場秩序。糾察員或保全人員在場協助維持秩序時,應佩戴「糾察員」字樣臂章或識別證。

會場備有擴音設備者,股東非以本公司配置之設備發言時,主席得制止之。

股東(a)違反本規則不服從主席糾正,或(b)妨礙會議之進行經制止不從者,得由主席指揮糾察員或保全人員請其離開會場。

第十六條 (休息、續行集會)

會議進行時,主席得酌定時間宣布休息,發生不可抗拒之情事時,主席得裁定暫時停止會議,並視情況宣布續行開會之時間。

股東會排定之議程於議事(含臨時動議)未終結前,開會之場地屆時未能繼續使用,得由股東會決議另覓場地繼續開會。

股東會以視訊會議召開者,本公司應於投票結束後,即時將各項議案表決結果及選舉結果,依規定揭露於股東會視訊會議平台,並應於主席宣布散會後,持續揭露至少十五分鐘。

股東會以視訊會議召開者,主席應於宣布開會時,另行宣布除公開發行股票公司股務處理準則第四十四條之二十第四項所定無須延期或續行集會情事外,於主席宣布散會前,因天災、事變或其他不可抗力情事,致視訊會議平台或以視訊方式參與發生障礙,持續達三十分鐘以上時,應於五日內延期或續行集會之日期,不適用公司法第一百八十二條之規定。

發生前項應延期或續行會議,未登記以視訊參與原股東會之股東,不得參與延期或續行會議。

依規定應延期或續行會議,已登記以視訊參與原股東會並完成報到之股東,未參與延期 或續行會議者,其於原股東會出席之股數、已行使之表決權及選舉權,應計入延期或續 行會議出席股東之股份總數、表決權數及選舉權數。

依規定辦理股東會延期或續行集會時,對已完成投票及計票,並宣布表決結果或董事當 選名單之議案,無須重行討論及決議。

本公司召開視訊輔助股東會,發生無法續行視訊會議時,如扣除以視訊方式出席股東會 之出席股數後,出席股份總數仍達股東會開會之法定定額者,股東會應繼續進行,無須 延期或續行集會。

發生前項應繼續進行會議之情事,以視訊方式參與股東會之股東,其出席股數應計入出 席股東之股份總數,惟就該次股東會全部議案,視為棄權。

本公司依規定延期或續行集會,應依公開發行股票公司股務處理準則第四十四條之二十 第七項所列規定,依原股東會日期及各該條規定辦理相關前置作業。

第十七條 (訂定和修訂程序)

本規則應於本公司向臺灣證券交易所(或證券櫃檯買賣中心)或其他相關主管機關提出申請股票第一上市(或興櫃股票櫃檯買賣)或申報辦理公開發行時起(以孰早者為準)自動生效,其修正應經股東會通過。惟,依相關法令辦理申報公告事宜,於本公司股票於臺灣證券交易所(或證券櫃檯買賣中心)正式上市掛牌交易(或興櫃股票櫃檯買賣)或於台灣公開發行時起(以孰早者為準),始適用之。

第十八條 (法令變動)

如有與本規則所訂事項相關之中華民國法令有所變動,該新修正之法令應優先於本規則 相關條款之適用,且本公司應依該新修正之法令修改本規則,並將該修正案提交下次股 東會通過。

There shall not be votes which are limited to class, party or sector, and any Member shall have the freedom to specify whether to concentrate all of its votes on one or any number of candidate(s) without restriction. A candidate to whom the ballots cast represent a prevailing number of votes shall be deemed a Director elect, and where more than one Director is being elected, the top candidates to whom the votes cast represent a prevailing number of votes relative to the other candidates shall be deemed directors elect. - 3.3. 本公司董事之選舉,如有二人以上得權相同時,由得權相同者抽籤決定之,未 出席者由主席代為抽籤。
- 3.4. 選舉開始前應由主席指定監票員及記票員若干人,執行各有關任務。選舉用之 投票櫃(箱)由本公司備製,並應於投票前由監票員當眾開驗,但監票員應具 有股東身分。
- 3.5. 選舉票由董事會製備,選舉人之記名得以在選票上所印出席證號碼代之,並加 填其權數。
