參、附件

一、一〇二年度營業報告書

民國 102 年，是茂林光電力求突破的一年，正當 TV 市場往直下式靠攏的同時，茂林側入式 LED 導光板的出貨量仍有年增 3 成的好表現。雖然整體的營收及獲利較 101 年度略微下滑，但擴大產品線多元應用的機會卻已悄然浮現，除車載、家電、IT 產業之外，還有時下最夯的穿戴式裝置等等，都是茂林光電的導光板更多元化應用與發展的舞台。

茂林光電長期策略將持續不斷的投入更多光學技術之研發，與擴展更寬廣的產品應用領域，期許打造茂林光電成為一個穩定且能永續經營的國際級公司。

一、財務表現：

本公司民國 102 年全年度合併營收為新台幣 44 億 4 仟 6 佰萬餘元，平均毛利率為 21%；稅後淨利為新台幣 2 億 1 仟 7 佰萬餘元，稅後盈餘為每股新台幣 1.57 元。

二、技術及研發概況：

102 年度之研發成果：1. LED TV 擴散式導光板押出製程開發

2. 超薄 IT 用導光板開發

3. 車載導光板產品開發

面對全球市場對直下式 TV 需求激增的壓力，本公司積極開發的擴散式導光板應用技術，除了厚度比傳統的直下式更薄之外，更可減少 LED 顆數，以此更輕、薄、節能的領先技術及成本降低的優勢，期望能取代傳統直下式成為下一波 TV 應用的主流。

掌握關鍵製程與導光技術，新產品的開發，如 IT 產業、車載裝置等，將可達到光學應用的最佳化、且符合節能省電之最高標準。

三、未來展望：

目前在世界各國積極推動環保節能政策趨勢下，低效率、高能耗的光源將逐步被高效率、低能耗、低成本的光源所取代。預期未來導光板應用產品的相關需求將會持續成長。除 LED TV 之外，舉凡資訊、車載、照明與通訊等消費性 3C 產品導光板的終端應用，皆為茂林積極搶佔的市場。

今年茂林將持續擴增 TV 導光板的生產線，提高產能以滿足市場需求，預期推升 TV 導光板出貨數量 10% 以上的成長、並達到滲透率 15% 的目標。

第一條 目的

本公司為激勵員工及提昇員工向心力，依據證券交易法第二十八條之二第一項第一款及金融監督管理委員會證券期貨局發佈之「上市上櫃公司買回本公司股份辦法」等相關規定，訂定本公司買回股份轉讓員工辦法。本公司買回股份轉讓予員工，除依有關法令規定外，悉依本辦法規定辦理。

第二條 轉讓股份權利內容及受限情形

本次轉讓予員工之股份為普通股，其權利義務除有關法令及本辦法另有規定外，與其他流通在外普通股相同。

第三條 轉讓期間

本次買回之股份，得依本辦法之規定，自買回股份之日起三年內，一次或分次轉讓予員工。

第四條 受讓人之資格

凡於認股基準日前到職滿六個月之本公司及持股 100%之從屬公司之正式員工，對公司有特殊貢獻經提報本公司董事長同意之本公司及持股 100%之從屬公司員工，得依本辦法第五條所訂定認購數額，享有認購資格。受讓之對象於員工認股基準日至認購繳款截止日期間離職(或留職停薪)者，喪失認購資格。

第五條 員工受讓股數之訂定

本公司考量員工職務與職責及對公司之特殊貢獻，並能與公司長期發展等標準，訂定員工受讓之股數，並呈報本公司董事長核決之。

第六條 轉讓之程序

1. 依董事會之決議、公告、申報並於執行期限內買回本公司股份。
2. 公司董事長依本辦法訂定及公佈員工認股基準日、可認購股數標準、轉讓價格、認購繳款期限、權利內容等作業事項。
3. 統計實際認購繳款股數、辦理股票轉讓過戶登記。

第七條 每股轉讓價格

本次買回股份轉讓予員工，以實際買回之平均價格為轉讓價格。惟在轉讓前，如

(一)、 按關係人交易價格加計必要資金利息及買方依法應負擔之成本。所稱必要資金利息成本，以公司購入資產年度所借款項之加權平均利率為準設算之，惟其不得高於財政部公布之非金融業最高借款利率。

- (二)、關係人如曾以該標的物向金融機構設定抵押借款者，金融機構對該標的物之貸放評估總值，惟金融機構對該標的物之實際貸放累計值應達貸放評估總值之七成以上及貸放期間已逾一年以上。但金融機構與交易之一方互為關係人者，不適用之。

- (二)、關係人訂約取得不動產時間距本交易訂約日已逾五年。
- (三)、與關係人簽訂合建契約而取得不動產。

- 三、本公司向關係人取得不動產依本條第二項（一）、（二）規定評估結果均較交易價格為低時，應依本條第四項規定辦理。但如因下列情形，並提出客觀證據及取具不動產專業估價者與會計師之具體合理性意見者，不在此限：

- 1、關係人係取得素地或租地再行興建者，得舉證符合下列條件之一者：

- (1)、素地依前條規定之方法評估，房屋則按關係人之營建成本加計合理營建利潤，其合計數逾實際交易價格者。所稱合理營建利潤，應以最近三年度關係人營建部門之平均營業毛利率或中華民國財政部公布之最近期建設業毛利率孰低者為準。
- (2)、同一標的房地之其他樓層或鄰近地區一年內之其他非關係人成交案例，其面積相近，且交易條件經按不動產買賣慣例應有之合理樓層或地區價差評估後條件相當者。
- (3)、同一標的房地之其他樓層一年內之其他非關係人租賃案例，經按不動產租賃慣例應有合理之樓層價差推估其交易條件相當者。

- 2、本公司舉證向關係人購入之不動產，其交易條件與鄰近地區一年內之其他非關係人成交案例相當且面積相近者。前述所稱鄰近地區成交案例，以同一或相鄰街廓且距離交易標的物方圓未逾五百公尺或其公告現值相近者為原則；所稱面積相近，則以其他非關係人成交案例之面積不低於交易標的物面積百分之五十為原則；前述所稱一年內係以本次取得不動產事實發生之日為基準，往前追溯推算一年。

- 四、本公司向關係人取得不動產，如經按本條第二項及第三項規定評估結果均較交易價格為低者，應辦理下列事項：

- (一)、應就不動產交易價格與評估成本間之差額，依中華民國證券交易法第四十一條第一項規定提列特別盈餘公積，不得予以分派或轉增資配股。對公司之投資採權益法評價之投資者如為公開發行公司，亦應就該提列數額按持股比例依中華民國證券交易法第四十一條第一項規定提列特別盈餘公積。
- (二)、審計委員會應依中華民國公司法第二百十八條規定辦理。
- (三)、應將第（一）款及第（二）款處理情形提報股東會，並將交易詳細內

容揭露於年報及公開說明書。

五、本公司向關係人取得不動產，依前項規定提列特別盈餘公積者，應俟高價購入之資產已認列跌價損失或處分或為適當補償或恢復原狀，或有其他證據確定無不合理者，並經中華民國行政院金融監督管理委員會（下稱「金管會」）同意後，始得動用該特別盈餘公積。

六、本公司向關係人取得不動產，若有其他證據顯示交易有不合營業常規之情事者，亦應依前二項規定辦理。

第十條 取得或處分會員證或無形資產之處理程序

一、取得或處分會員證或無形資產應經董事會核准。

惟於緊急狀況需要時，本公司董事會授權董事長得運用其裁量於取得本公司董事會事前核准前決行之。於此情況，該取得或處分會員證或無形資產應報經最近一次董事會追認之。

二、取得或處分會員證或無形資產應先經研發及財務部門審核及評估後，取得董事會同意後執行。

三、本公司取得或處分會員證或無形資產之交易金額達公司實收資本額百分之二十或新臺幣叁億元以上者，應於事實發生日前洽請會計師就交易價格之合理性表示意見；會計師並應依會計研究發展基金會所發布之審計準則公報第二十號規定辦理。

第十之一條 前三條(取得或處分不動產或其他固定資產、取得及處分有價證券投資及取得或處分會員證或無形資產)交易金額之計算，應依第十四條第二項規定辦理，且所稱一年內係以本次交易事實發生之日為基準，往前追溯推算一年，已依本程序規定取得專業估價者出具之估價報告或會計師意見部分免再計入。

第十一條 透過法院拍賣程序取得或處分資產之處理程序

本公司透過法院拍賣程序取得或處分資產，可將法院核發之相關證明文件用以代替估價報告及會計師意見書。

第十二條 取得或處分衍生性商品交易之處理程序

一、類型

本公司不得辦理任何非屬本程序第三條第一項所訂類型商品之交易。

二、策略

衍生性商品交易，限於營運避險所必須。

三、核准及授權

負責交易衍生性商品之財務人員應由財務長指定。

衍生性商品之交易、確認及平倉應由財務部不同人員執行。

交易及確認人員之指定及解任需於生效日前通知交易相對人。

交易之授權及核准層級如下：

各交易之授權金額

董事會 超過美金二千萬元

財務長 不超過且包括美金二千萬元

惟於緊急狀況需要時，本公司董事會授權董事長得運用其裁量於取得本公司董事會事前核准前決行之。於此情況，該取得或處分衍生性商品應報經最近一次董事會追認之。

四、金額及損失金額限制

避險目的

衍生性商品合約金額總額不得超過未來一年因業務所產生之應收應付款項或資產負債就幣別互抵後之淨部位。從事衍生性商品交易之全部契約及個別契約損失以不超過其交易總金額 10% 為上限，如損失達交易金額 10% 時，須立即呈報董事長，研議因應措施，並於事後向董事會報告。各子公司亦同。

交易目的

本公司辦理衍生性商品交易之目的，限於營運避險所必須，且不應進行交易目的之衍生性商品交易。

五、績效評量

避險目的

衍生性商品交易應根據事先訂定之策略評量績效。

六、風險管理衡量

(一)、信用風險管理

信用風險應以限制交易相對人為與本公司有銀行業務往來或是國際知名且可提供足夠資訊之公司之方式加以管理。

(二)、市場／價格風險管理

因利率、匯率及其他因素所帶來之市場／價格風險應被嚴密監控。

(三)、流動性風險管理

流動性風險應以限制交易相對人為有足夠資金額度、充足的資訊及大量的交易量，並且能夠於全球進行相關交易之方式加以管理。

(四)、現金流量風險管理

本公司應維持足夠的速動資產及信用額度以滿足平倉需求。

(五)、訴訟風險管理

任何關於衍生性商品交易之法律文件應於簽署前先經由內部或外部法律顧問核閱以管理訴訟風險。

(六)、營運風險管理

(1) 負責衍生性商品交易之人員及確認、交割等作業人員不得互相兼任。

(2) 風險之評量、監督及控制應由與前款不同部門之人員負責並報告給董事會或非負責衍生性商品交易或決策持有部位之高階主管人員。

(3) 衍生性商品交易持有部位應至少每週評估一次；但因營運避險需求之衍生性商品部位應至少每月評估二次。評估報告應提交給董事會指派之高階主管人員。

七、本公司從事衍生性商品交易，董事會應依下列原則確實監督管理：

(一)、指定高階主管人員應隨時注意衍生性商品交易風險之監督與控制。

(二)、定期評估從事衍生性商品交易之績效是否符合既定之經營策略及承擔之風險是否在公司容許承受之範圍。

董事會授權之高階主管人員應依下列原則管理衍生性商品之交易：

(一)、定期評估目前使用之風險管理措施是否適當並確實依本程序辦理。

(二)、監督交易及損益情形，發現有異常情事時，應採取必要之因應措施，並立即向董事會報告；董事會應有獨立董事出席並表示意見。

本公司於授權相關人員依本程序從事衍生性商品交易後，應提報董事會。

- 八、本公司從事衍生性商品交易，應建立備查簿，就從事衍生性商品交易之種類、金額、董事會通過日期及依本條第六項第六款第三目、第七項第一項第二目及第二項第一目應審慎評估之事項，詳予登載於備查簿備查。
- 公司內部稽核人員應定期瞭解衍生性商品交易內部控制之允當性，並按月稽核交易部門對從事衍生性商品交易處理程序之遵循情形，作成稽核報告，如發現重大違規情事，應以書面通知審計委員會。

第十三條 辦理合併、分割、收購或股份受讓之處理程序

- 一、本公司辦理合併、分割、收購或股份受讓，應於召開董事會決議前，委請會計師、律師或證券承銷商就換股比例、收購價格或配發股東之現金或其他財產之合理性表示意見，提報董事會討論通過。
- 二、本公司應將合併、分割或收購重要約定內容及相關事項，於股東會開會前製作致股東之公開文件，併本條第一項之專家意見及股東會之開會通知一併交付股東，以作為是否同意該合併、分割或收購案之參考。但依其他法律規定得免召開股東會決議合併、分割或收購事項者，不在此限。

參與合併、分割或收購之公司，任一方之股東會，因出席人數、表決權不足或其他法律限制，致無法召開、決議，或議案遭股東會否決，參與合併、分割或收購之公司應立即對外公開說明發生原因、後續處理作業及預計召開股東會之日期。

- 三、參與合併、分割或收購之公司除其他法律另有規定或有特殊因素事先報經金管會同意者外，應於同一天召開董事會及股東會，決議合併、分割或收購相關事項。

參與股份受讓之公司除其他法律另有規定或有特殊因素事先報經金管會同意者外，應於同一天召開董事會。

本公司參與合併、分割、收購或股份受讓，應將下列資料作成完整書面紀錄，並保存五年，備供查核：

- (一) 人員基本資料：包括消息公開前所有參與合併、分割、收購或股份受讓計畫或計畫執行之人，其職稱、姓名、身分證字號（如為外國人則為護照號碼）。
- (二) 重要事項日期：包括簽訂意向書或備忘錄、委託財務或法律顧問、簽訂契約及董事會等日期。
- (三) 重要書件及議事錄：包括合併、分割、收購或股份受讓計畫，意向書或備忘錄、重要契約及董事會議事錄等書件。

參與合併、分割、收購或股份受讓時，本公司應於董事會決議通過之即日起算二日內，將前款（一）、（二）之資料（依規定格式以網際網路資訊系統）申報金管會備查。

參與合併、分割、收購或股份受讓之公司有非屬上市或股票在證券商營業處所買賣之公司者，本公司應與其簽訂協議，並依本項第三款及第四款規定辦理。

- 四、所有參與或知悉公司合併、分割、收購或股份受讓計畫之人，應出具書面保密承諾，在訊息公開前，不得將計畫之內容對外洩露，亦不得自行或利用他人名義買賣與合併、分割、收購或股份受讓案相關之所有公司之股票及其他具有股權性質之有價證券。

- 五、本公司參與合併、分割、收購或股份受讓，換股比例或收購價格除下列情形外，不得任意變更，且應於合併、分割、收購或股份受讓契約中訂定得變更

之情況如下：

- (一) 辦理現金增資、發行轉換公司債、無償配股、發行附認股權公司債、附認股權特別股、認股權憑證及其他具有股權性質之有價證券。
 - (二) 處分公司重大資產等影響公司財務業務之行為。
 - (三) 發生重大災害、技術重大變革等影響公司股東權益或證券價格情事。
 - (四) 參與合併、分割、收購或股份受讓之公司任一方依法買回庫藏股之調整。
 - (五) 參與合併、分割、收購或股份受讓之主體或家數發生增減變動。
 - (六) 已於契約中訂定得變更之其他條件，並已對外公開揭露者。
- 六、本公司參與合併、分割、收購或股份受讓，契約應載明參與合併、分割、收購或股份受讓公司之權利義務，並應載明下列事項：
- (一) 違約之處理。
 - (二) 因合併而消滅或被分割之公司前已發行具有股權性質有價證券或已買回之庫藏股之處理原則。
 - (三) 參與公司於計算換股比例基準日後，得依法買回庫藏股之數量及其處理原則。
 - (四) 參與主體或家數發生增減變動之處理方式。
 - (五) 預計計畫執行進度、預計完成日程。
 - (六) 計畫逾期未完成時，依法令應召開股東會之預定召開日期等相關處理程序。
- 七、參與合併、分割、收購或股份受讓之公司任何一方於資訊對外公開後，如擬再與其他公司進行合併、分割、收購或股份受讓，除參與家數減少，且股東會已決議並授權董事會得變更權限者，參與公司得免召開股東會重行決議外，原合併、分割、收購或股份受讓案中，已進行完成之程序或法律行為，應由所有參與公司重行為之。
- 八、參與合併、分割、收購或股份受讓之公司有非屬公開發行公司者，本公司應與其簽訂協議，並依本條第三項、第四項及第七項規定辦理。

第十四條 資訊公開及重大訊息揭露程序

- 一、本公司取得或處分資產，有下列情形者，應按性質依規定格式，於事實發生之即日起算二日內將相關資訊於金管會指定網站辦理公告申報：
- (一) 向關係人取得或處分不動產，或與關係人為取得或處分不動產外之其他資產且交易金額達公司實收資本額百分之二十、總資產百分之十或新臺幣三億元以上。但買賣公債或附買回、賣回條件之債券，不在此限。
 - (二) 進行合併、分割、收購或股份受讓。
 - (三) 從事衍生性商品交易損失達所訂處理程序規定之全部或個別契約損失上限金額。
 - (四) 除前三款以外之資產交易、金融機構處分債權或從事大陸地區投資，其交易金額達公司實收資本額百分之二十或新臺幣三億元以上者。但下列情形不在此限：
 - (1) 買賣公債。
 - (2) 以投資為專業者，於海內外證券交易所或證券商營業處所所為之有價證券買賣。

- (3) 買賣附買回、賣回條件之債券。
- (4) 取得或處分之資產種類屬供營業使用之機器設備且其交易對象非為關係人，交易金額未達新臺幣五億元以上。
- (5) 以自地委建、合建分屋、合建分成、合建分售方式取得不動產，公司預計投入之交易金額未達新臺幣五億元以上。

二、前項交易金額依下列方式計算之：

- (一) 每筆交易金額。
- (二) 一年內累積與同一相對人取得或處分同一性質標的交易之金額。
- (三) 一年內累積取得或處分（取得、處分分別累積）同一開發計畫不動產之金額。
- (四) 一年內累積取得或處分（取得、處分分別累積）同一有價證券之金額。

三、前項所稱「一年內」係以本次交易事實發生之日為基準，往前追溯推算一年，已依本準則規定公告部分免再計入。

四、本公司應按月將本公司及其非屬國內公開發行公司之子公司截至上月底止從事衍生性商品交易之情形依規定格式，於每月十日前輸入金管會指定之資訊申報網站。

五、本公司依規定應公告項目如於公告時有錯誤或缺漏而應予補正時，應將全部項目重行公告申報。

六、本公司取得或處分資產，應將相關契約、議事錄、備查簿、估價報告、會計師、律師或證券承銷商之意見書備置於本公司，除其他法律另有規定者外，至少保存五年。

七、本公司依本條第一項至第六項規定公告申報之交易後，有下列情形之一者，應於事實發生之日起算二日內將相關資訊於金管會指定網站辦理公告申報：

- (一) 原交易簽訂之相關契約有變更、終止或解除情事。
- (二) 合併、分割、收購或股份受讓未依契約預定日程完成。
- (三) 原公告申報內容有變更。

第十五條 本公司之子公司非屬國內公開發行公司，取得或處分資產有第十四條規定應公告申報情事者，由本公司為之。

前項之子公司適用第十四條第一項應公告申報標準有關達實收資本額百分之二十或總資產百分之十規定，應以本公司實收資本額或總資產為準。

第十六條 本公司之子公司在執行取得或處分資產程序時應依本程序規定辦理。

本公司應監督子公司建立相關取得或處分資產程序。子公司取得或處分資產相關資訊應定期回報給本公司。

第十七條 本公司負責取得或處分資產之執行人員如有違反本程序相關規定者，應根據其違反之情形依公司內部規定，定期報告、核閱及懲處。

第十八條 訂定和修改

- 一、本程序應於本公司向臺灣證券交易所（或證券櫃檯買賣中心）或其他相關主管機關提出申請股票第一上市（或興櫃股票櫃檯買賣）或申報辦理公開發行時起（以孰早者為準）自動生效。惟，依相關法令辦理申報公告事宜，於本公司股票於臺灣證券交易所（或證券櫃檯買賣中心）正式上市掛牌交易（或興櫃股票櫃檯買賣）或於台灣公開發行時起（以孰早者為準），始適用之。

- 二、本程序經審計委員會通過後，送董事會決議並提報股東會同意，如有董事表示異議且有記錄或書面聲明者，本公司應將其董事異議資料送審計委員會並提報股東會討論，修正時亦同。倘中華民國法令就本程序所訂事項有所變動，該新修正之法令應取代本程序中之相關規定，且審計委員會及董事會應依據該新修正之法令修訂本程序，並將該等修訂提報股東會同意。
- 三、依前項規定將本程序提報董事會討論時，應充分考量各獨立董事之意見，獨立董事如有反對意見或保留意見，應於董事會議事錄載明。
- 四、訂定或修正本程序，應經審計委員會全體成員（以實際在任者計算之）二分之一以上同意，並提董事會決議。前項如未經審計委員會全體成員（以實際在任者計算之）二分之一以上同意者，得由全體董事（以實際在任者計算之）三分之二以上同意行之，並應於董事會議事錄載明審計委員會之決議。

第十九條 內部控制稽核重點

- 1. 本公司取得或處分不動產或其他固定資產之評估程序是否依規定辦理。
- 2. 向關係人購買或交換而取得不動產之程序，是否依規定辦理。
- 3. 取得或處分資產之交易金額達公司實收資本額百分之二十或新台幣三億元以上時，財務部是否於事實發生之日起算二日內，依法辦理公告申報作業。
- 4. 非屬國內公開發行之子公司，其取得或處分資產達本處理程序所規定應公告申報情事者，本公司應為公告申報事宜。

三、股東會議事規則

第一條、(前言)：

為建立本公司良好股東會治理制度、健全監督功能及強化管理機能，爰訂定本股東會議事規則（下稱「本規則」），以資遵循。

第二條、(總則)：

除相關法令或本公司章程大綱及公司章程（下稱「章程」）另有規定者外，本公司股東會議事應依本規則之規定。

所有於本規則中使用但未加以明確定義之用語，均與其在章程中之意義相同。

第三條、(股東會之召集及通知程序)：

本公司股東會除法令或章程另有規定外，由董事會召集之。

董事會經繼續一年以上持有已發行股份總數百分之三以上股份之股東依章程規定請求董事會召集股東臨時會而於股東提出請求日起十五日內未為股東臨時會召集之通知時，提出請求之股東得依據公開發行公司法令，自行召集股東臨時會。

股東會之召集，應編製議事手冊，並依相關法令和章程規定之時間與方式，於股東會十五日前將議事手冊及其他相關資料於中華民國證券主管機關指定之公開資訊觀測站公告申報之。股東會召集之通知，常會應於開會日之三十日前通知各股東，臨時會應於十五日前通知各股東。

通知及公告應載明召集事由；其通知經股東事前同意者，得以電子方式為之。

與下列有關之事項應載明於股東會通知並說明其主要內容，且不得以臨時動議提出：

- 一、選舉或解任董事；
- 二、修改章程；
- 三、解散、合併或分割；
- 四、訂立、修改或終止關於出租本公司全部營業，或委託經營，或與他人經常共同經營之契約；
- 五、讓與本公司全部或主要部份之營業或財產；
- 六、受讓他人全部營業或財產而對本公司營運有重大影響者；
- 七、許可董事為其自己或他人從事本公司營業範圍內事務之行為；
- 八、以發行新股方式分配本公司全部或部分盈餘、法定公積及其他依本公司章程規定款項之資本化；
- 九、本公司私募發行具股權性質之有價證券。

第四條、(委託書)：

股東得依據本公司章程以本公司核准之格式之委託書，載明授權範圍，委託代理人，出席股東會，並載明該委託書僅為特定股東會所為。

委託書格式內容應至少包括填表須知、股東委託行使事項及股東、受託代理人及徵求人（若有）基本資料等項目，委託書用紙並應與股東會召集通知同時提供予股東，並應於

同日分發予所有股東。

一股東以出具一委託書，並以委託一人為限，應於股東會開會五日前送達本公司登記處所或送達股東會召集通知或本公司寄出之委託書上所指定之處所，委託書有重複時，以最先送達者為準。但股東在後送達的文件中明確以書面聲明撤銷前委託者，不在此限。委託書送達本公司後，股東欲親自出席股東會者，應於股東會開會二日前，以書面向本公司為撤銷委託之通知，該通知應敘明撤銷委託之原因係因被代理人於出具委託書時不具行為能力或不具委託權力或其他事由；逾期撤銷者，以委託代理人出席行使之表決權為準。

第五條、(召開地點及時間)：

股東會應於董事會指定之時間及地點召開，惟除法令另有規定外，股東會應於中華民國境內召開。

如董事會決議在台灣境外召開股東會，相關程序及核准應依中華民國相關主管機關之規定辦理。於中華民國境外召開股東會時，本公司應提供股東以書面投票或電子傳送方式行使投票權之方法，並應於中華民國境內委託專業股務代理機構，受理該等股東會行政事務（包括但不限於受理股東委託投票事宜）。

第六條、(文件備置)：

本公司應於開會通知書載明受理股東報到時間、報到處地點，及其他應注意事項。

前項受理股東報到時間至少應於會議開始前三十分鐘辦理之；報到處應有明確標示，並派適足適任人員辦理之。

股東本人或股東所委託之代理人(以下稱股東)應憑出席證、出席簽到卡或其他出席證件出席股東會；屬徵求委託書之徵求人並應攜帶身分證明文件，以備核對。

本公司應設簽名簿供出席股東簽到，或由出席股東繳交簽到卡以代簽到。

本公司應將議事手冊、年報、出席證、發言條、表決票及其他會議資料，交付予出席股東會之股東；有選舉董事、監察人者，應另附選舉票。

政府或法人為股東時，出席股東會之代表人不限於一人。法人受託出席股東會時，僅得指派一人代表出席。

第七條、(股東會主席、列席人員)：

股東會如由董事會召集者，其主席應由董事長擔任之，董事長請假或因故不能行使職權時，由副董事長代理之，無副董事長或副董事長亦請假或因故不能行使職權時，由董事長指定董事一人代理之，董事長未指定代理人或所指定之代理人因故不能行使代理職權時，應由其他出席之董事互推一人代理之。股東會如由董事會以外之其他召集權人召集者，主席由該召集權人擔任之，召集權人有二人以上時，應互推一人擔任之。

董事會所召集之股東會，宜有董事會過半數之董事參與出席。

本公司得指派所委任之律師、會計師或相關人員列席股東會。

第八條、(股東會法定出席股份數)：

股東會之出席，應以股份為計算基準。出席股數依簽名簿或繳交之簽到卡，加計以書面或電子方式行使表決權之股數計算之。

已屆開會時間，主席應即宣布開會，惟除本公司章程另有規定及不違反公開發行公司法令之規定外，若於指定為股東會會議之時間開始時出席股東代表股份數未達法定出席股份數，或於股東會會議進行中出席股東代表股份數未達法定出席股份數者，主席得宣布延後開會，但其延後次數以二次為上限，且延後時間合計不得超過一小時。如股東會經延後二次開會但出席股東代表股份數仍不足法定出席股份數時，主席應宣布該股東會流會。如仍有召集股東會之必要者，則應依本公司章程規定重行召集一次新的股東會。

第九條、(議案討論)：

股東會如由董事會召集者，其議程由董事會訂定之，會議應依排定之議程進行，非經股東會決議不得變更之。

於相關之股東名冊停止過戶期間前持有已發行股份總數百分之一以上股份之股東，得以書面向本公司提出一項股東常會議案，如(a)提案股東持股未達已發行股份總數百分之一；(b)該議案非股東會所得決議；(c)提案股東提案超過一項者；或(d)該提案於公告受理期間外提出者，提案不列入議程。

股東會如由董事會以外之其他有召集權人召集者，準用本條第一項之規定。

第一項及第三項排定之議程於議事（含臨時動議）未終結前，非經決議，主席不得逕行宣布散會；主席違反本規則，宣布散會者，董事會其他成員應迅速協助出席股東依法定程序，以出席股東表決權過半數之同意推選一人擔任主席，繼續開會。

股東會主席對於議案及股東所提之修正案或臨時動議，應給予充分說明及討論之機會，認為已達可付表決之程度時，得宣布停止討論，提付表決。

本公司應將股東會開會之過程全程錄音或錄影並保存影音資料應至少一年，遇有與股東會召集程序不當或不當通過決議有關之訴訟情事時，應保存至訴訟終結為止。前述之保存方式得以電子檔案形式為之。

第十條（股東發言）

出席股東發言前，須先填具發言條載明發言要旨、股東戶號（或出席證編號）及戶名，由主席定其發言順序。

出席股東僅提發言條而未發言者，應視為該股東未發言。發言內容與發言條記載不符者，應以實際發言內容為準。

同一議案每一股東發言，非經主席之同意不得超過兩次，每次不得超過五分鐘，惟股東發言違反規定或超出議題範圍者，主席得制止其發言。

出席股東發言時，其他股東除經徵得主席及發言股東同意外，不得中斷該發言股東之發言，違反者主席應予制止。

法人股東指派二人以上之代表出席股東會時，同一議案僅得推由一人發言。

出席股東發言後，主席得親自或指定相關人員答覆。

第十一條（表決股數之計算、迴避制度）

除章程另有規定外，股東會之表決依下述規定及第12條規定辦理。股東會之表決，應以股份為計算基準。

股東會之決議，對依章程或法令規定無表決權股東之股份數，不算入已發行股份之總數。股東對於股東會討論之事項，有自身利害關係且其利益可能與本公司之利益衝突者，就其所持有的股份，不得在股東會上就該議案加入表決，並不得代理他股東行使其表決權。前項不得行使表決權之股份數，不算入已出席股東之表決權數。但為計算法定出席股份數門檻之目的，此等股份仍應計入出席該股東會股東所代表之股份數。

除章程另有規定或章程或本規則所列無表決權者外，股東每股有一表決權。

除依據中華民國法律組織之信託事業或章程規定之公開發行公司規則核准之股務代理機構外，一人同時受二人以上股東委託時，其代理之表決權不得超過股票停止過戶前本公司已發行股份總數表決權之百分之三，超過時其超過之表決權，應不予計算。為避免疑義，依章程規定由本公司委任之股務代理機構所代表之股份數應不受本公司已發行股份總數表決權之百分之三之限制。

第十二條（行使表決權及決議之方式）

股東每股有一表決權；但受限制或公司法第一百七十九條第二項所列無表決權者，不在此限。

本公司董事會得決定本公司召開股東會時，股東得以書面投票或電子方式行使其表決權；惟如表決權得以書面投票或電子方式行使時，表決權行使方法應載明於股東會召集通知。股東依前開規定以書面投票或電子方式行使其於股東會之表決權時，應視為親自出席該次股東會。但就該次股東會之臨時動議及/或原議案之修正，此等股東無權受通知以及無權行使表決權。為避免疑義，以此種方式行使表決權之股東應視為已拋棄其就該次股東會之臨時動議及/或原議案之修正之通知及表決權之權利。

前項以書面投票或電子方式行使表決權之股東，其意思表示應於股東會開會二日前送達公司，同一股東有超過一個之表示時，以最先送達者為準。但該股東較晚送達之表示有明確之書面聲明撤銷前表示者，不在此限。

股東依前項規定將其以書面投票或電子方式行使表決權之意思表示送達公司後，嗣後如欲親自出席股東會者，應於股東會開會二日前以與行使表決權相同之方式撤銷前項行使表決權之意思表示。逾期撤銷意思表示者，以書面投票或電子方式行使之表決權為準。如以書面投票或電子方式行使表決權並以委託書委託代理人出席股東會者，以委託代理人出席行使之表決權為準。

除章程或本規則另有規定外，議案之表決應依出席股東表決權數過半數之同意通過之。表決時，應逐案由主席或其指定人員宣佈出席股東之表決權總數。

同一議案有修正案或替代案時，由主席併同原案定其表決之順序。如其中一案已獲通過時，其他議案即視為否決，勿庸再行表決。

議案表決之監票及計票人員，由主席指定之，但監票人員應具有股東身分。

股東會表決或選舉議案之計票作業應於股東會場內公開處為之，且應於計票完成後，當場宣布表決結果，包含統計之權數，並作成紀錄。

第十三條（選舉或解任事項）

股東會有選舉或解任董事時，應依本公司章程辦理，並應當場宣布選舉或解任結果。

前項選舉或解任之選舉或表決票，應由監票人及主席密封簽字後至少保存一年，遇有與股東會召集程序不當或不當通過決議有關之訴訟情事時，應保存至訴訟終結為止。

第十四條（股東會議事錄）

股東會之議決事項，應作成議事錄，由主席簽名或蓋章，並於會後二十日內，將議事錄分發各股東。議事錄之製作及分發，得以電子方式為之。

前項議事錄之分發，本公司得以公告方式為之。

議事錄應確實依會議之日期（年、月、日）、場所、主席姓名、決議方法、議事經過之要領及其結果記載之，並應保存至少一年，遇有與股東會召集程序不當或不當通過決議有關之訴訟情事時，應保存至訴訟終結為止。

第十五條（會場秩序之維護）

辦理股東會之會務人員應佩帶識別證或臂章。

股東會得設置糾察員或保全人員並由主席指揮協助維持會場秩序。糾察員或保全人員在場協助維持秩序時，應佩戴「糾察員」字樣臂章或識別證。

會場備有擴音設備者，股東非以本公司配置之設備發言時，主席得制止之。

股東(a)違反本規則不服從主席糾正，或(b)妨礙會議之進行經制止不從者，得由主席指揮糾察員或保全人員請其離開會場。

第十六條（休息、續行集會）

會議進行時，主席得酌定時間宣布休息，發生不可抗拒之情事時，主席得裁定暫時停止會議，並視情況宣布續行開會之時間。

股東會排定之議程於議事（含臨時動議）未終結前，開會之場地屆時未能繼續使用，得由股東會決議另覓場地繼續開會。

第十七條（訂定和修訂程序）

本規則應於本公司向臺灣證券交易所（或證券櫃檯買賣中心）或其他相關主管機關提出申請股票第一上市（或興櫃股票櫃檯買賣）或申報辦理公開發行時起（以孰早者為準）自動生效，其修正應經股東會通過。惟，依相關法令辦理申報公告事宜，於本公司股票於臺灣證券交易所（或證券櫃檯買賣中心）正式上市掛牌交易（或興櫃股票櫃檯買賣）或於台灣公開發行時起(以孰早者為準)，始適用之。

第十八條（法令變動）

如有與本規則所訂事項相關之中華民國法令有所變動，該新修正之法令應優先於本規則相關條款之適用，且本公司應依該新修正之法令修改本規則，並將該修正案提交下次股東會通過。
